



iHypnosis™ Partner Program Agreement

This Agreement ("Agreement") is entered into by and between:

- Company: iHypnosis™, operated by Jakub Tencl, Sole Trader, Trademark Owner (hereafter referred to as 'Company')
- Partner: The individual or entity who registers through the iHypnosis Partner Portal and agrees to the terms herein (hereafter referred to as 'Partner').

1. Purpose and Appointment

The Company appoints the Partner as a non-exclusive independent contractor authorized solely to promote and sell iHypnosis products and services through approved methods, subject to the terms and conditions set forth herein.

2. Registration, Access, and Verification

Partner must register through the official Partner Portal: <https://partners.ihypnosis.org.uk>
Email verification is required before full access is granted.

The Company may accept, suspend, or terminate any Partner registration at its sole discretion.

3. Sales Process and Commission

After making a sale, the Partner must immediately log the sale via the Partner Portal. Partner either collects full payment directly (if authorized) or refers the sale to the Company.

Upon confirmation:

- Partner retains 40% commission.
- Partner sends 60% of the payment to the Company within 48 hours.

Shipping costs are deducted before calculating commission.

Commissions are paid monthly within 30 days.



4. Payment Instructions:

After logging a sale, the Partner must transfer 60% of the full sale value to the Company within 48 hours.

Fulfilment of customer orders will only begin once the Company has received full payment of its 60% share for the transaction.

5. Fulfilment

The Company fulfils products or services once payment is received and the sale is logged.

Fulfilment is conditional upon receipt of the Company's 60% payment.

Shipping risks and delays beyond the Company's control are excluded from liability.

6. Partner Conduct and Brand Representation

Partners must represent iHypnosis honestly, ethically, and professionally.

Use only approved marketing materials.

No medical claims.

Respect customer privacy.

Uphold a respectful brand image on social media.

7. Intellectual Property

All trademarks, logos, and content remain the property of the Company.

Partner has a limited, revocable license to use materials for promotion.



8. Confidentiality

The Partner must maintain strict confidentiality regarding Company information indefinitely beyond termination.

9. Liability and Indemnification

The Partner indemnifies the Company against claims arising from breaches or misconduct.

10. Term and Termination

Either party may terminate the Agreement with 14 days' written notice.
Immediate termination for breach or unethical conduct.

11. Independent Contractor Status

The Partner acts as an independent contractor and is responsible for taxes and compliance.

12. Governing Law

This Agreement is governed by the laws of the United Kingdom.
Disputes are subject to the courts of England and Wales.
